## WPA Comments on Proposed Changes to Livestock Siting Rule

On September 13, the Wisconsin Pork Association joined ten other farm and agribusiness organizations and filed joint comments expressing concerns,

about recently proposed revisions to Wis. Admin. Code s. ATCP 51, Wisconsin's livestock facility siting law.

The Department's review was done as a part of the statutorily directed four-year review of ATCP 51. DATCP convened a Technical Expert Committee (TEC) in December 2018 to review the current ATCP 51 standards and to make recommendations for changes or updates. The statutory review is guided by the livestock facility siting statute, which was enacted "...for the purpose of providing uniform regulation of livestock facilities." Wis. Stat. s. 93.90.

WPA and the other farm groups jointly expressed concern that the draft rule was developed by a technical expert committee that did not include any farmer representatives and that some of the most critical aspects of the proposed revisions were not tested on actual Wisconsin farms.

The proposed rule would abandon the current odor management standard, which relies on an odor score along with setbacks, in favor of a new system that relies on drastically increased setbacks with the possibility of credits for certain odor control practices. According to the joint comments, the farm groups believe that this is the most significant and unworkable change made in the hearing draft. The threat that expanded setbacks pose to the growth of livestock agriculture is increased by measuring distances from property lines, as opposed measuring from a person who can perceive an odor. The current odor scoring system is measured from the location of the nearest odor receptor, such as a neighboring residence.

Essentially, under the proposed revised rule, the only option for farmers who cannot meet the increased setbacks is to try to seek a local variance. The farm groups expressed concern that this could return the livestock siting process to local decision-makers who may or may not have the expertise to evaluate a proposal and also would create the precise situation that the livestock siting law was created to avoid - inconsistent local regulation.

In addition to the joint comments, WPA also filed individual comments during the public comment period. In these comments, WPA expressed concern that the rule proposal would require waste storage structures to be completely emptied in order to be inspected. For hog under-barns, where waste is stored under the animal housing, completely emptying the waste storage structure would require the farmer to depopulate the barn (i.e., send the entire herd to slaughter) and wash and remove all

manure from the pit. These structures are not designed to be completely emptied for inspection. They are designed to be inspected while in use. The proposed emptying process risks potentially damaging the storage facilities with sludge removal and this requirement is both costly and unnecessary.

The proposed revisions also differentiate between animal housing types by classifying them either "Category 1" or "Category 2" livestock housing based on the odor generation numbers. WPA objected to the classification of deep pit hog barns as Category 1 because they are deemed to generate more odor than other structures and, therefore, require larger setback distances. WPA asked that the Department review actual odor and air emissions studies in order to more accurately evaluate hog barns.

On September 19, the DATCP Board received a report from Department staff on the comments that were received at the public hearings and during the public comment period. It is expected that a revised draft rule will be brought back to the DATCP Board for their review at their November 7, 2019 meeting.

WPA will continue to be engaged in this rule revision as it progresses. Thank you to all of our farmers and members who testified at the public hearings and attended the DATCP Board meetings.

#### POPEYE BURGER

1 6 oz pkg fresh spinach, chopped
2 cloves garlic, minced
1 cup feta cheese
3/4 cup quick-cooking oats
1/2 cup diced onion
1 lb ground pork

1 Tbsp olive oil
1/2 cup mayo
1 egg
1/2 tsp salt
1/4 tsp pepper
4 brioche buns

Set aside 1 cup spinach. In skillet over medium heat, add remaining spinach and garlic. Cook until just wilted. About 2 minutes. Transfer to small bowl and add mayo. Chill covered for about 30 minutes. Whisk together egg, reserved cup of spinach, cheese, oats, onion, salt & pepper and mix with your hands until well blended. Form the pork mixture into four patties and cook.

# Last Call- PRRS/PEDV Testing Grant

The Wisconsin Pork Association is offering \$25 grants to pork producers to help offset costs of testing for Porcine Reproductive and Respiratory Syndrome and Porcine Epidemic Diarrhea Virus. Testing is required to comply with changes to Wisconsin's Animal Health rule, which became effective in early 2018. The rule change requires farms with pigs to test for PRRS and PEDv when moving from one premise to another within Wisconsin, or for pigs coming into the state. Testing is not required for farms who only move pigs directly to slaughter. The funding is available on a first-come-first serve basis. Producers may apply for one grant each quarter of the year.
