2027 Pork Act Delegate Election Public Notice

The election of pork producer delegate candidates for the 2027 National Pork Producers (Pork Act) Delegate Body will take place at 11:00 AM, Thursday, January 29th, 2026, in conjunction with the Wisconsin Pork Association’s Annual Meeting at the Kalahari Resort, 1305 Kalahari Drive, Wisconsin Dells, WI. All Wisconsin pork producers are invited to attend. Any producer, age 18 or older, who is a resident of the state and has paid all assessments due may be considered as a delegate candidate and/or participate in the election. All eligible producers are encouraged to bring with them a sales receipt proving that hogs were sold in their name and the checkoff deducted. WPA Board of Directors Election

The WPA Board of Directors consists of pork producers and at least one allied industry member. The Board sets policies and provides direction to the staff for program development and implementation. Board members are eligible to serve two consecutive three-year terms. There will be **three** vacant seats to be voted on during the annual meeting. Terms expire at the annual meeting within the respective term year. Individuals with unexpired terms, a term with less than 3 years, are eligible to run for two full terms at the completion of their unexpired term. One full term is the completion of three (3) years on the board. Each district must have at least one producer director. There may be up to 6 at-large directors from any district. There must be at least one allied industry director, but no more than three.

WPA Proposed Resolutions

The following resolutions will be presented and voted on by WPA membership during the annual meeting. These resolutions are the roadmap for WPA's legislative priorities for 2026 at the state level. Members are encouraged to review the following proposed resolutions prior to the annual meeting. If you have questions, please call WPA at 608-723-7551 or email wppa@wppa.org.

26-1 Applied Agricultural Research – Motion: Whereas WPA supports ongoing scientific research in the areas of applied agricultural science, WPA:

- supports continued funding for state integrated specialists who are faculty or instructional academic staff at the University of Wisconsin-Platteville, University of Wisconsin-River Falls, University of Wisconsin-Stevens Point or University of Wisconsin-Madison College of Agricultural and Life Sciences who are also staff at the Division of Extension at the University of Wisconsin-Madison in the field of applied agricultural research; and
- supports funding for applied agricultural research at both the University of Wisconsin-Madison College of Agricultural and Life Sciences and the University of Wisconsin System campuses.

Rationale: Pressure on Wisconsin farmers to change farming practices in response to a wide variety of environmental concerns is increasing. However, adaptation of farm practices must be based on sound science that accounts for and balances both economic and environmental concerns. As such, we need to continue to support and strengthen our applied agricultural research community in Wisconsin and in our university system.

26-2 Groundwater Quality – Motion: As the focus in Wisconsin increases on the sources, effects, and remediation efforts to support quality groundwater, WPA:

- supports sound science as the basis for any discussion about proposed best management practices or regulations related to addressing farming as a source of any contaminants in groundwater;
- supports a statewide program to provide well remediation for rural drinking water;
- supports the development of peer-reviewed scientific research to identify the sources, effects, and remediation efforts;
- urges state and federal policymakers to exercise extreme caution regarding any regulations related to agriculture and PFAS in the state of Wisconsin;
- asks that state and federal policymakers ensure that innocent landowner protections are extended to farmers who spread materials containing PFAS on agricultural lands;
- encourages state and federal regulators to prioritize the importance of preserving productive agricultural land throughout the state of Wisconsin; and
- supports local, state, and federal financial and technical assistance for farmers whose livelihoods may be threatened by PFAS exposure and who want to voluntarily assess their risk.

Rationale: Quality groundwater in Wisconsin is a statewide public health concern that potentially affects all WPA members.

26-3 Livestock Siting – ATCP 51 – Motion: Whereas the existing livestock facility siting standard establishes regulatory certainty for new and expanding hog farms in Wisconsin through the use of clear statewide standards; WPA

- supports the maintenance of facility siting standards that are consistent statewide and are scientifically defensible, thereby providing a solid framework for farms to grow.

Rationale: Following a four-year review of the Livestock Facility Siting Rule, DATCP may propose revisions to the standard, which should be carefully reviewed by livestock farms, environmental groups, and local units of government in order to ensure that the livestock facility siting rule continues to provide an understandable and predictable process for siting new and expanding livestock farms across Wisconsin.

26-4 Animal Health – Motion: Whereas it is in the best interest of Wisconsin's swine industry to continue to explore options to mitigate animal health impacts to the industry and threats to public health, WPA:

- supports continued monitoring of disease threats;
- supports the Wisconsin State Legislature providing General Purpose Revenue funding to DATCP in an amount to support adequate staff and resources for the Division of Animal Health;
- supports ongoing review of swine disease control efforts to determine their effectiveness; and
- supports revising swine disease testing protocols and regulations as needed.

Rationale: Wisconsin is in the right position to take further steps to control and reduce the prevalence of diseases.

26-5 Local Livestock Moratoria and Ordinances – Motion: Whereas WPA encourages planned agricultural growth at the local level, WPA:

- supports township and county boards to continue to adopt Wisconsin's Livestock Facility Siting ordinance; and,
- opposes moratoria or livestock operational ordinances at the local level that hinder siting livestock farms or livestock farm expansions.

Rationale: Fewer Wisconsin residents have direct links to agriculture and, as a result, have less knowledge about on-farm practices. Supporting a diverse agricultural economy that includes locally grown commodities, organic farming, conventional agriculture and concentrated animal feeding operations, benefits all involved in agriculture. The State of Wisconsin provides local units of government with tools to regulate the siting of livestock operations through zoning and Wis. Admin. Code s. ATCP 51, the livestock facility siting standard.

26-6 Renewable Energy – Motion: As governments and communities begin to focus more on expanding sources of renewable energy, WPA is committed to producing pork in a sustainable way that:

- supports farmers choosing to voluntarily adopt technologies to reduce carbon emissions and increase energy efficiency;
- supports voluntary, incentive-based programs that support energy sustainability while also supporting continued farm profitability and production;
- supports the development of new technologies that are based on science;
- supports governmental and regulatory agencies reviewing and considering all potential effects on farm production and profitability, the agricultural land base and impacts to food production in every renewable energy project analysis; and
- supports farmer participation in renewable energy projects as long as such participation is voluntary, does not place any undue economic or regulatory burden on Wisconsin farmers, and any economic impact statement is paid for by applicant for the renewable energy project, not by the farmer.

Rationale: Wisconsin farmers recognize the need to support a strong foundation of voluntary energy stewardship investments and practices that are balanced against the needs of crop and livestock systems.

26-7 Healthcare Coverage – Motion: Whereas more and more Wisconsin farmers are struggling to afford healthcare coverage for themselves, their families, and their employees, WPA:

- supports state and federal legislative efforts to expand options for affordable healthcare coverage for Wisconsin farmers including legislation allowing the Wisconsin Farm Bureau Federation to offer a Health Benefit Plan to members.

Rationale: Because of the way that farm income is calculated under the federal Affordable Care Act (ACA), many farmers are ineligible for rebates thereby making coverage proportionately very expensive. Similarly, healthcare coverage costs on the private market are rising and becoming increasingly unaffordable. As such, farmers often go without healthcare coverage, cannot offer it to their employees, or choose to have a family member work off the farm to get employer-sponsored coverage.

26-8 Siting Wind and Solar Projects – Motion: Whereas there are an increasing number of solar and wind projects being sited and proposed to be sited across the state of Wisconsin, WPA:

- supports the inclusion of an “agricultural impact analysis” done by the Wisconsin Public Service Commission as a part of any proposed utility scale wind or solar project that analyzes the effects the proposed project would have on acres of agricultural land in production, agricultural land prices and impacts to the food supply and agricultural supply chain; and
- further supports efforts to prioritize the use of rooftop solar and other non-farmland areas to site solar and wind installations and that will minimize the number of acres removed from production agriculture for energy projects in Wisconsin.

Rationale: Wisconsin farmers recognize the need to increase renewable energy production capacity, but farmers believe that preservation of productive farmland must also be a priority in order to minimize impacts to food security, optimize land use, ensure long-term sustainability of farming and avoid detrimental economic impacts to farmers.

26-9 Rural Pharmacies – Motion: Whereas a significant number of independent and retail pharmacies in rural communities have been closing, WPA:

- recognizes the vital importance of rural pharmacies and urges policymakers, healthcare stakeholders, and community leaders to take immediate and sustained action to preserve and support these essential healthcare providers;
- supports legislative or regulatory efforts to address pharmacy benefit manager (PBM) practices that negatively impact rural pharmacies;
- supports policies that will ensure the financial viability of rural policies;
- encourages partnerships between rural pharmacies and other healthcare providers to expand access to care; and
- supports policies that will public awareness about the challenges facing rural pharmacies and the critical role they play in their communities.

Rationale: Rural pharmacies play a critical role in providing essential healthcare services to underserved and geographically isolated communities, not only providing prescription medications but also immunizations, over-the-counter medications, counseling services, and health screenings, which are important to supporting the health and livelihoods of Wisconsin farmers and their families.

26-10 Fire Suppression Regulations – Motion: Whereas changes to the National Fire Protection Association’s (NFPA’s) NFPA 150, Fire and Life Safety in Animal Housing Facilities Code, 2026 edition, include requirements for automatic fire suppression sprinkler systems in animal housing facilities, WPA:

- opposes any change to state or local fire or plumbing codes that would codify or mandate a similar animal housing sprinkler system requirement in Wisconsin.

Rationale: Mandating sprinkler systems in livestock barns creates both biosecurity and equipment functionality issues due to required periodic inspections, maintenance and possible shut down of ventilation which is a major animal welfare concern.

26-11 Food Labeling – Motion: Whereas consumers have a right to understand the source, method of production, and nature of the food products they purchase and transparency in food labeling supports informed decision-making by allowing consumers to distinguish between meat produced through traditional animal agriculture and meat grown or cultivated using laboratory, cellular, or synthetic methods, WPA:

- supports the establishment of clear, uniform food labeling standards requiring explicit notification when meat has been grown, cultivated, or produced in a laboratory setting;
- supports labeling policies that protect the viability of naturally raised meat products by ensuring consumers can readily differentiate them from lab-grown alternatives;
- urges federal agencies and policymakers to prioritize transparency, consumer education, and fair competitiveness through the adoption of such standards.

Rationale: Establishing clear labeling standards benefit consumers, retailers, farmers, and processors through reduced confusion and increased transparency and helps preserve fair market competition by ensuring that lab-grown products are not marketed in a manner that implies equivalence to traditionally raised livestock products without explicit disclosure.

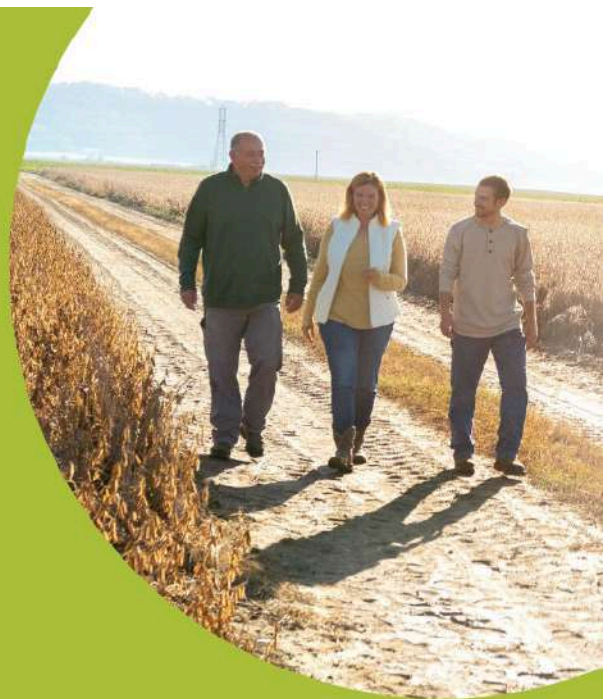

NPPC Looking Ahead into 2026

Picking up stalled momentum from 2025, farm bill negotiations are expected to resume in January. NPPC will continue to push for a stop to the impending patchwork of state animal housing laws spurred by California's Proposition 12. All other NPPC farm bill priorities were signed into law in the One Big, Beautiful Bill in July – including vital animal health and trade programs.

The Trump administration will release the Dietary Guidelines for Americans, which makes diet recommendations and advises government feeding programs, including schools and the military, on what and how much food to consume. The Guidelines will likely include a formal definition for “ultra-processed foods,” which NPPC asserts, among other things, should not demonize processed pork products.

House Agriculture Committee Chairman G.T. Thompson (R-PA) is expected to introduce a bill to help with the lack of available farm workers, focusing on revising the H-2A program with recommendations by the House Agriculture Committee's Agricultural Labor Working Group, with which NPPC partnered closely.

USDA is expected to release a proposed rule to make permanent the New Swine Inspection System increased line speed program for all U.S. pork processing plants. Without this program, some pork producers could have incurred an additional loss of nearly \$10 a head.

On the trade front, NPPC continues to engage with the administration to support pork exports by negotiating new market access agreements. NPPC is reiterating support for and monitoring discussions around the mandatory 2026 review of USMCA.

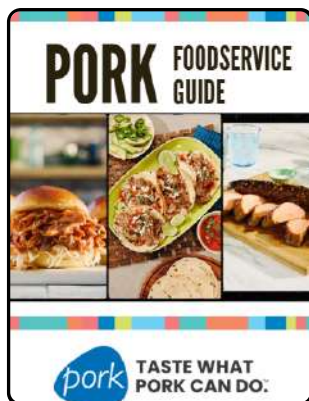

WPA 2025 Year in Review – Checkoff

What a year 2025 was! On the Checkoff side we hosted many successful events, promoted the new Taste What Pork Can Do brand, created new retail partnerships, and grew our youth programs. Mandatory Checkoff dollars are authorized for promotion, education and research. The Checkoff rate is \$.35/\$100 of value when pigs are sold or imported, and a percentage of the funds are returned to the state pork associations. The Pork Checkoff is overseen by National Pork Board (NPB). Read on to learn about how your hard-earned dollars were put to use in Wisconsin and beyond in 2025.



WPA developed a Pork Foodservice Guide that was distributed to over **600 foodservice professionals** in WI and **several hundred more** across the U.S.

WPA attended 4 major promotion events reaching over **1 million people**.

Partnered with Piggly Wiggly influencer to promote pork. **Fresh pork sales rose 12%, 11% & 23%** respectively, during all three promotions.

Awarded **thirty-seven** \$50 mini-grants to Family Consumer Science teachers to promote pork in their classrooms.



TASTE WHAT PORK CAN DO.

NPB launched the new **Taste What Pork Can Do™** brand in May, and WPA amplified the brand in several of its communications and promotion events. Although only seven months in, the brand has shown exceptional results in driving demand for pork especially amongst Millennials and Gen Z consumers.

Sold over **20,500 pieces of pork** during Wisconsin State Fair which was good considering poor weather and the last day being canceled!



WPA hosted 6 producer educational events and 3 producer luncheons allowing us to meet with **over 300 producers, members, and youth**.

We awarded \$100 Youth Pig Project scholarships to **50 young people**.



WPA collected **188 test results** for PRRS and PEDv and awarded rebates to all producers who submitted results to help further study the effect of these diseases in WI.

Promoted the Wisconsin Raised program signed up **8 processors**.

WPA enrolled 20 producers in the Pork Cares Farm Impact Sustainability Report program which accounted for **36,225 head of pigs & 4,617 acres**.

WPA 2025 Year in Review – Unrestricted

On the unrestricted side we were busy advocating for the farm bill, for state budget inclusions benefitting agriculture and strengthening partnerships to enhance the pork industry's image. Strategic Investment Program (SIP) dollars are unrestricted which allows us to respond to issues that threaten our right to farm on local, state, and national levels. The current SIP investment is \$.15/\$100 of value when pigs are sold, and 40% of the funds are returned to the states. National Pork Producers Council (NPPC) oversees the SIP program. Luke Wall is our Regional Director of Producer Services that coordinates SIP in our state. At the state level, WPA is a member of the Ag Coalition which is comprised of ag groups working toward common legislative goals. Jordan Lamb, an attorney with The Welch Group, is our lobbyist at the state-level. Read on to learn more about how SIP, membership, and sponsorship dollars were invested in 2025.



Attended NPPC's **Legislative Action Conference** in Washington D.C. to advocate for the farm bill, a Prop 12 fix, FAD preparedness programs, and labor reform. Attended Ag Day at the Capitol in Madison.



Worked with DATCP on pending rule revision to **repeal WI PRRS / PEDv testing requirements.**



Hosted our 26th annual Pork Classic Golf Outing which welcomed **50 golfers.**



Worked cohesively with other commodity groups in the **Wisconsin Ag Coalition** to achieve the following successes:

Awarded **\$6,500** in scholarships to **seven young people** across Wisconsin.

- Secured an additional \$150 million for the ARIP Grant Program
- \$2 million for the Producer-Led Watershed Grant Program
- \$10 million Food Security Initiative grants
- \$200,000 to support farmer mental health
- \$1 million in additional funding for Meat Processor Grants
- \$2.4 million for Meat Inspection Program
- \$2 million for the Nitrogen Optimization Pilot Program (NOPP) grants
- \$1.6 million for the Cover Crop Insurance Premium Rebate Program
- Additional \$500,000 for CDL Driver Training Grants

Pushed USDA to reject change to Packers and Stockyards Act

Secured amendments to California AB1264 definition of ultra processed foods

Grew bipartisan support for federal solution to Prop 12

Championed efforts to make packing plant line speeds program permanent

Successful registration renewals for U.S. pork facilities exporting to China

Spearheaded coalition that secured passage of Beagle Brigade Act

Collected producer input for development of National Swine Health Strategy

Adoption of international standard for ASF vaccines

Led efforts for funding increases in House committee-passed agriculture appropriations bill

Championed trade policy that broke 2023 export record

Won Supreme Court judgement against EPA overreach in Clean Water Act case

Secured major victory in long-fought legal effort to uphold air reporting exemptions

Persuaded EPA to shelve burdensome effluent guidelines and standards

Fought for market access in U.S. and EU Trade Framework & increased market access in Indonesia, Japan, the Philippines, and Malaysia
